

**How to Request A Public Record Pursuant to the Illinois Freedom of Information Act**

Any person or entity requesting a public record from the Village must submit a written request either by mail or facsimile. Every requester is encouraged, but not required, to use the Villages FOIA form when submitting a FOIA request. Each person or entity requesting a public record should clearly state and describe the record in enough detail so that an employee can locate the record. Requests will be responded to within five (5) business days.

**Allowable Fees Under the FOIA (5 ILCS 140/6)**

In certain circumstances, public entities may charge a fee for the production of public records. Some common examples include:

- After the first 50 pages, black and white letter or legal sized copies shall be \$.015 per page.
- Color copies or copies in a size other than letter or legal shall be no more than the actual cost of reproducing the requested records.
- Electronic copies request shall be the actual cost of purchasing the recording medium.
- The cost for certifying a record shall not exceed \$1.00
