
In recent years the Village of Monee has moved with the ebb and flow of growth in the south suburbs of the Chicagoland area. With the last housing boom, the community saw the introduction of new parks and open spaces as part of new home developments and a 75% growth in population since the year 2000, according to the U.S. Census Bureau. A recreation facility was built, full-time parks & recreation leadership hired, and youth sports programming and general recreational programming became a central focus for the Village of Monee Parks and Recreation Department. **The time is right for a Village of Monee Parks & Recreation Comprehensive Plan.**

As Monee moves through its process of creating a Comprehensive Plan for the Village overall, it is essential that this Parks and Recreation Comprehensive Plan become an integral component. Resources, such as grants, donations and sponsorships to support Parks and Recreation depend highly upon the availability of clear plans for the Parks & Recreation Department, and a long-term commitment from Village Trustees. This Parks and Recreation Comprehensive Plan will develop guidelines for parks and recreation decision-making, and provide direction for short-term and long-term goals. This plan is meant to be progressive and adaptable, and able to accommodate the changing recreational needs of the residents of Monee. The Parks and Recreation Department, along with Village Administration, has the opportunity to make changes if needed.

If plans for the Parks and Recreation Department are not a part of the overall Village plan, then it will ignore the necessity to identify and integrate those with all the other essential services in Monee:

- The resources necessary for Public Works to provide for ongoing maintenance of existing parks (Firemen's, Friendship, Potawatomi, and Sunrise).
- The resources necessary to take care of the current facilities (Recreation Center, Shelters/Pavilions, Concession, Baseball Diamonds, Football/Soccer fields, etc.).

The American Planning Association says this about the role of parks and recreation in the management and growth of our communities:

"Parks are commonly thought of as the venue for "fun and games," but that is only one role they play in a metropolitan environment. Public understanding of the pivotal role that parks play in enhancing the quality of life in our cities is growing, along with an understanding of the links between the quality of parks and sprawling growth on the fringe of cities. City parks are an important element of smart growth that addresses both the public's need for greenspace and the role of greenspace in mitigating higher development density."

While Monee Parks and Recreation certainly provides opportunities for community "fun and games", some stakeholders feel they are not here to entertain the residents of Monee. It is essential to also recognize the economic, social, and planning benefits that a successful Parks and Recreation department brings to Monee. Businesses and individuals looking to locate/re-locate in a community base their decisions on a short list of key factors:

1. Good Schools
2. Safe Neighborhoods
3. Infrastructure
4. Taxes and Related Development Costs
5. **Recreation and Parks**
6. Access to Transportation and Shopping

Research has shown that property values increase by 8% when a community has quality parks and recreation services, and according to real estate professionals, while the quality of roads, policing, sewer and water are important, the quality of schools and parks and recreation are what make the difference in selecting where to live. Other statistics from *The 2018 Americans' Engagement with Parks Report* done by the National Recreation and Park Association that are important for the future of a vibrant Monee include:

- 85% of Americans consider high quality park and recreation amenities important factors when choosing a new place to live.
- More than 9 in 10 Americans agree that parks and recreation is an important local government service.
- 76% percent of Americans are more likely to vote for local politicians who make park and recreation funding a priority.
- 78% of survey respondents indicate they want their local governments to increase park and recreation spending, especially if it helps ensure all Americans are within a 10-minute walk to a great park.

The Village of Monee will see great value by planning for, and insuring, quality parks and recreation as it plans for the future.





Project Timeline

The team began the Comprehensive Plan process in February of 2020. Existing documents and maps related to Parks and Recreation were gathered from the Village, and additional research was done to gather information on community demographics, community history, parks and recreation offerings, and Monee's Parks and Recreation operations and budget. The team recognizes the importance of community input and involvement in the development of the Comprehensive Plan so interviews were conducted of staff members and key community leaders. Community members were able to provide input through an online parks and recreation survey and in-person at a public meeting held at Village Hall.

Overview

The Master Plan team compiled and reviewed plans and documents pertaining to parks, recreation, open space, and other cultural and recreational programs offered in Monee. The team analyzed existing sources of data, including community demographics, quality and convenience of park and facility locations, existing natural resources, and Monee Parks and Recreation Department operations and budget. Evaluation also included comparing Monee's park and recreational offerings to those of other similarly sized nearby municipalities.

Community Profile

Founded in 1874 by a vote of the population in the area, the First Village Board was voted into Office with President Edward Wernigh, and Trustees Henry Hoffman, Charles Plagge, Phillip Vollmar, Christopher Schoenstedt, and August Schiffer. The Clerk was William T. Hutchinson, the Treasurer, Baio Hayen, and the Police Magistrate was Laban Easterbrooks.

Five years later, in 1879, the Monee Court Hall was built, but not until 1884 was a Fire Department created, when the population was just less than 500.

It wasn't until 1908 when the first organized Parks & Recreation Department made history as the Monee Amusement Co. leased Ziemer's Grove section of Raccoon Grove and laid out a picnic grounds and baseball diamond. Also constructed was a large pavilion for dancing. It was named Oakdell Park. Furthermore, on July 4th the first picnic was held at Oakdell Park. Unfortunately, later that same year the Oakdell Park pavilion was destroyed by fire, but joyously rebuilt in August. This park was used until about 1918.

In 1909, the Monee Driving Park Association purchased a 26-acre tract of land east of town. There was a grandstand built with a seating capacity of 800. It became the Monee Fair Grounds, and the first fair was held in September.

While, park lands were being established, so were recreation organizations. In fact, the men's basketball team of the Monee Athletic Club were area champions in 1913.

In 1920, the population of Monee was 395—lower than in 1895! This same year, a new Auditorium at the Monee Fairgrounds was opened.

Unfortunately, this auditorium then burned down in 1934.

Just two years later, in 1922, work began on a new railroad line running north-south through Monee that became known as “the cut.” It bisects the Village and still exists today.

In 1937, land was bought by the Forest Preserve District of Will County to form a public park, which is still in use today.

The Fire Department purchased 5-acres of land and three lots for \$6,000 along Court Street in 1950. On this land stood a 5-room stone building, “The Creamery”, which in the late 1800’s had been a cheese factory. This area was already widely known as Lankenau’s Park since the family owning the property leased it as picnic grounds. The Fire Department developed the acreage into a community park with baseball diamond and tennis court now known as Firemen’s Park and began recreational programming. Annually, for almost 20 years, a large festival was held at the park and the entire town came together for this 3-day event.

In 1959, the Illinois Division of Highways announced the building of Interstate 57, which would cross north-south through Monee Village limits west of “the cut.” I-57 from Kankakee to I-80 won’t open still until 1968.

With the introduction of modern utilities, post office, businesses, schools, the railroad line, and Interstate 57, the population of Monee grows steadily from 1960-1990 from 647 residents to 1,044 residents.

It is estimated that in the late 90s, both Potawatomi Park and Sunrise Park were established when the land surrounding them was subdivided and homes built. Friendship Park was likely established in the early 2000s.

By the year 2000, the population of Monee reached almost 3,000 people and steady growth in housing developments for the community continued until the 2008 recession and housing market crash. In 2010, the population of Monee peaked at 5,148 residents.

The following year, the “Save the Creamery Foundation” established to save the Monee Creamery building in Firemen’s Park from demolition. The Monee Creamery Building was finally granted landmark status by Will County in 2016 and plans began for renovation. In 2017, the “Save the Creamery Foundation” organization morphed into the Monee Historical Society.





Monee, IL 2017





Parks and Recreation in Monee is on the cusp of moving to the next phase of growth in meeting the needs of its residents. Several key indicators from the Village Community-wide Resident Survey contribute to this generalization, including:

- 56% of survey respondents have participated in at least one Village of Monee Parks and Recreation program in the last year.
- 85% of survey respondents feel that the Village of Monee should continue to invest in the parks and recreational programming.
- 89% of survey respondents indicate they are willing to pay for recreation programming.

Additionally, across the interview spectrum with Trustees and Staff of the Village of Monee there was consistent support for, and strong positive sentiment towards the progress that parks and recreation has made in Monee in recent years. Staff attributes this to the support of the Trustees and the Trustees attribute this to the Village's investment and commitment to staffing and growing the Parks and Recreation Department for success.

Charged with giving the Village some perspective on how it is doing in terms of Parks & Recreation services, we sought to research a variety of factors. Benchmarking—the concept of seeing how one entity is doing in relationship to others of similar form and function (EAV, Population, etc.)—allows us to see if there are stark departures from what others are doing that might demonstrate a need for improvement. A great way to assess oneself is to see how others are doing to give perspective toward planning and improvement over time.

Toward this end, it might help for the Village of Monee to see how they compare:



All these factors are very interesting, and demonstrate that the Village is neither a trend setter, nor far behind “the curve” in the provision of parks and recreation. However, nothing should distract from the progress of the Village towards improving the quality of life of Monee residents through planning—long-term—for improved Parks and Recreation service.

Many stakeholders indicated they felt Monee residents were going to other communities to participate in recreation programming. Research has found, in fact, that most families will travel up to 10 miles to participate in a variety of recreational programs, so this is likely happening. Nonetheless, Monee Parks and Recreation must also realize that it can offer unique programs that will draw others from towns up to 10 miles away.

This 5 and 10 mile “Radius Map” (opposite page) shows the potential range from which Monee Parks and Recreation can draw future customers. Additionally, Monee should be heartened to learn that only 16% of its resident survey respondents indicated they were going to other communities for their recreation programming—not as significant as many had thought.

There were several other key factors that stood out in the review of existing conditions, and the analysis of the operations which are crucial to the continued success of Parks and Recreation at the Village of Monee. The keys to future success in Monee will be tied to its ability to carefully bite off no more than it can chew when taking its next steps in provision of parks and recreations services:

- Carefully choosing which priorities will have the greatest impact for the investment of taxpayer dollars is crucial.
- Carefully balancing a financial commitment to assets and day-to-day operating issues is essential.
- Carefully taking the time to focus, first, on existing structure, management, assets and programming—bringing them into the 21st Century—before stepping out too far into “new” facilities and programs will assure that when future growth is sought, residents will be supportive and appreciative.

Based upon our assessment of existing conditions, the following factors stand out:

ADMINISTRATION

- The Parks and Recreation Director mainly focuses their time on Recreation.
- The Public Works Director maintains the parks.
- Lack of “Visibility” of the Department leads to numerous complications:
 - » Lack of Independent Media to Promote Parks and Recreational Programs
 - » Lack of Parks and Recreation “Brand” or “Motto” to help it stand out from all the other quality services provided by the Village causes challenges
 - » No Online Registration
- Active Participation, by the Parks and Recreation Director, at the Village Board level is limited.
- Key Policy Matters at the Village Level related to Parks and Recreation need updating.
- Key legal documents, land records, and ordinance matters need attention.
- Trustees appear strongly supportive of Parks and Recreation progress and future planning.
- The current Director must move from her main role as a Program Leader to a Director who sets a long-range course and vision for both Parks and Recreation.



RECREATION

- A significant number of individuals as reported in the survey fall into the category of “Detractors” in terms of the Parks and Recreation Department but not because of bad experiences, and rather due mainly to:
 - » Lack of variety of programming
 - » Not knowing what is available
 - » Not having developed an opinion, as of yet, as to the department
- Programming is quite aggressive for the size of the community.
- Versatility of indoor space for programming is limited.
- No clear assessment of success/failure rates of programming, a fee policy, or costing methods exist.
- Defining “Core Services” is recommended:
 - » Narrow and focus.
 - » Set program and age group priorities.
- Affiliations and Partnerships could lead to additional/future indoor recreation program space.
- Fewer residents are going to other agencies (YMCA, other Villages or Park Districts, etc.) than Staff and Trustees seemed to think.



PROGRAM SPECIFIC

- Having conducted a three-year assessment of recreation programs that were offered by the Village of Monee (see Appendix) which measured:
 - » Programs Offered by Age Group
 - » Number of Programs Offered
 - » Program Enrollment
 - » Success Rate of Programs Offered—Cancellations versus Successfully run programs
 - » Type of Program Offered (i.e., Sport vs Arts, Social vs. Skill-Specific)
- There were 116 special events and programs offered.

By Program Type:

37% of Programs Offered Were Visual or Performing Arts
31% of Programs Offered Were Sports Oriented
16% of Programs Were Special Events
6% of Programs Were Social Activities
5% of Programs Were Health/Fitness Related
5% Remainder Were Made Up Of Technical and Continuing Education Topics

By Age Group:

36% of Programming was for Ages 5 to 12
13% of Programming was for Middle School Ages
12% of Programming was for High School Ages
12% of Programming was for Under Age 5
9% of Programming was for Active Older Adults (Ages 55 to 72)
6% of Programming was for Older Adults (Over Age 72)
6% of Programming was for Adults Ages 25 to 55
6% of Programming was for Young Adults Age 18 to 25



PARKS

- “Taking Care of What You Have”, first, is key.
- Firemen’s Park is a focal point for the community and needs the most extensive attention.
- Neighborhood parks are in good condition but are showing their age and have accessibility challenges.
- Several undeveloped and “unknown” open spaces exist in the Village, and hold great future potential.
- There are a lack of recreational spaces west of I-57 within Village limits.
- A small number of “new” parks facilities/amenities are a priority of the residents of the Village.
- Director of Parks and Recreation has the defined job of running Parks, but the Public Works Director has maintained the responsibility and authority to do so.
- Parks are one of numerous priorities of the Public Works Director, and can get lost in the shuffle.




Community Input

Community input is critical to creation of a successful Parks & Recreation Comprehensive Plan. A public meeting was held, and staff and community leaders interviewed. These interviews provided insight as to recurring themes in parks and recreation in Monee and helped to guide the direction of the plan. Additionally, input was gathered from community members and facility users through an online survey.

Public Meeting

At the start of the Comprehensive Plan development process, a public meeting regarding Parks & Recreation was held to inform the public the nature and purpose of a Comprehensive Plan for the Parks and Recreation Department. Approximately 20 residents attended the meeting on February 25th, 2020 at Village Hall including stakeholders of the Monee Mavericks Football Association, Golf Vista Senior Lifestyle Community, Crete-Monee School District 201-U and Monee Alliance of Churches. Three Village staff members and three Board Trustees were also in attendance.

The meeting opened with a brief introduction, an overview of the meeting objectives, and participants were encouraged to offer their ideas, concerns, and questions regarding Monee Parks and Recreation programs and facilities. The audience was informed that the Village Board and Administration are planning on applying for parks grants, such as the Open Space Land Acquisition and Development Grant (OSLAD) through the Illinois Department of Natural Resources (IDNR), to help fund park improvements and that a comprehensive plan is an essential component and first step in that process to lay out a framework for the future of parks and recreation in Monee.

It was agreed by most of the participants that the Village does have considerable assets in programs and makes the most of its limited facilities and resources. “Strengths” and “Needs” were further discussed and identified for parks, facilities, and recreational programming followed by a lengthy discussion focusing specifically on Firemen’s Park located directly adjacent to Village Hall. Lastly, discussion was held regarding the four neighborhood parks and Village-owned open space in Monee.

Strengths:

- Village staff; Parks & Recreation Director
- Nearby outdoor assets (Monee Reservoir; Raccoon Grove Forest Preserve)
- Strong young children’s programs
- Popular youth football and cheer organization (Monee Mavericks)
- Fall Fest in September
- “Movies in the Park”
- “Love Monee” service weekend
- “Music in the Park”

Needs:

- Recreation programs for older youth and teens
- Additional park and open space acreage
- More programs for girls’ sports
- Lack of multi-use paths and trails
- Leverage Village parks as “destination” for families – specifically to attract more demand to live in Monee
- Additional financial resources
- Historically a lack of vision about parks and rec in Monee – need to build a “culture of recreating”



Firemen's Park:

- Football and baseball field improvements
- Related field amenities (bleachers, dugouts)
- Modern, clean restroom facilities (there are none)
- Stormwater drainage improvements – especially to the football field
- Playground is past prime and not ADA code compliant
- Little security lighting now and need for lighting for night games and practices on baseball and football fields
- Need for indoor rec facility to offer programs, especially for teens
- ADA compliant walkways/access
- Improved parking lots (currently much is not paved)
- A walking path around the perimeter

“Firemen's Park is a place of “great potential” but in serious need of improvements and investments. Improving the existing facilities at Fireman's Park should take precedence in the next few years versus adding new park space.”

Additional parks and recreation desires:

- Plan for a bicycle route/path grid in Village that could connect with Forest Preserves
- Additional park acreage for playlots, fields for soccer, baseball, and softball.
- Improvement of current Village acreage designated for parks but undeveloped.

Finally, the participants were invited to prioritize overall their desired improvements and investments for the Monee Parks and Recreation Department. Many of these priorities were practical and measured, given the realistic resources available to the Village.

Overall Priorities:

1. Improve storm water drainage in Firemen's Park
2. Improve football and baseball fields at Firemen's Park
3. Build washrooms for men and women at Firemen's Park
4. Provide improved Firemen's Park lighting, especially adding field lights for baseball and football
5. Rebuild Firemen's Park Pavilion
6. Parking improvements at Firemen's Park
7. Convert Public Works building to indoor community Rec Center or build one elsewhere
8. Add additional parks (acreage) and open space in Village
9. ADA compliant walkways, playground and washrooms
10. Bicycle connectivity and paths



Staff and Stakeholder Interviews

Staff members, community leaders, and additional stakeholders were interviewed and asked 17 questions developed to help assess the strengths, weaknesses, opportunities and challenges of the Parks and Recreation department. Stakeholders were also asked to share their vision for the Parks and Recreation department regarding facilities and recreational programming, and specifically rank desired improvements to Firemen’s Park. A summary of responses to the questions were compiled and recurring responses were tallied (see Appendix for full summary). There were some clear priorities and themes identified for Parks and Recreation in Monee based on the summary of responses.

Community Survey

In late May of 2020, Farnsworth Group and Public Research Group together mailed out a postcard to residents of the Village of Monee asking them to participate in an online survey. There were approximately 22 questions developed; most questions required selecting from pre-determined ranges and answers with some opportunities for open-ended comments. The survey questions were designed to measure behavior as well as perceptions by residents surrounding mostly parks & facilities, but also included recreation and administration. Public Research Group sampled and processed 179 total survey responses. The full survey questionnaire and responses can be found in the Appendix.


SURVEY HIGHLIGHTS

- Parks & Recreation Department has not reached its full potential in meeting the expectations from the local community. Respondents' open-ended responses centered on not knowing what is available for parks & programming, a lack of variety in the programming specifically programs or activities for non-children households and a lack of special events.
- The parks are used frequently with Firemen's Park being the most visited.
- Park spaces seem very basic and do not generate much excitement for the average resident. The top three park features that are important to survey respondents to add or improve at Firemen's Park were a football field, playground equipment and a concession building.
- Residents would like to see an investment made into the parks with an expansion of recreation services offered.



AGE OF RESPONDENTS






This survey question is a measure of customer satisfaction and loyalty to the Village Parks & Recreation Department. The Net Promoter Score (NPS) system was used. NPS scores are measured with a single question survey and reported with a number from -100 to +100, a higher score is desirable. Given the NPS range of -100 to +100, a “positive” score or NPS above 0 is considered “Good”, +50 is “Excellent, and above 70 is considered “World Class.” Based on global NPS standards, any score above 0 would be considered “good.” The Parks & Recreation Department had a score of -51, which is considered a poor score with much work to be done in the future to raise this score.

FIREMEN’S PARK TOP THREE DESIRED FEATURES




MOST OFTEN USED MONEE PARKS



Village Board Prioritization Meeting

Upon analysis of information from Public Meeting 1, responses from the stakeholder interviews, and results of the community survey our team determined an interactive session was needed with Village staff and Trustees to present our findings, prioritize the recurring responses from these processes, and narrow the “wish list” for the Parks and Recreation Comprehensive Plan into a realistic strategy that can be planned for and implemented in the next five to ten years.

The highest-ranking responses were presented in two defined categories, Interview Findings and Community Survey Findings, each with two sub-categories of Capital Projects/Facilities and Management and Operating Factors (shown opposite page). The team reviewed each of the items listed with the group to ensure their full understanding of the items prior to conducting the ranking activity for each list.

The ranking activities allowed for each participant to move from their seats and place three stickers labeled with 1, 2, and 3 where 1 was “Most Important”, 2 was “2nd Most Important,” and 3 was “3rd Most Important.” There were obviously not enough stickers for all of the items in each list ensuring a clear definition of top priorities among participants. Once the activity concluded for each, discussion was conducted to record initial observations and then compare and contrast the Interview Findings versus the Community Survey Findings.



The final activity of the evening focused solely on improvements to Firemen’s Park. Based on all data gathered prior to this event, it is overwhelmingly clear that Firemen’s Park is a top priority for the Village of Monee, the Parks and Recreation Department and the community. What was lacking clarity is the priority for specific improvements and the order in which they should be planned for, if at all.

The Comprehensive Plan team created an overall list of the eight most desired park features. For the ranking activity, this time participants were given a total of 8 stickers numbered one through eight and were told to prioritize all items listed with 1 being the “Most Important” and 8 being the “Least Important” to them.

Additional amenities not listed as identified in the information gathering process, that could be potentially considered for future development beyond this list at Firemen's Park or at another location within Monee are: dog park, splash pad, basketball courts, volleyball courts, and soccer fields.



Establishing a Mission and Vision

The cornerstone of future progress in Parks & Recreation at the Village of Monee will lie in setting a MISSION and VISION for the next five years.

The current mission and Goals are:

Mission

The Mission of the Monee Parks and Recreation Department is to strive to maximize our resources to provide the community with high quality and economic leisure opportunities; through open space preservation, park development and recreational program offerings. “Take Time Out for Recreation...There’s No Place Like Monee.”

Goals

The goals of the Monee Parks and Recreation Department are to enact community relations through program and special events that are designed to:

- Advance the reputation and image of the Village
- Be responsive to the recreational needs of all individuals
- Build relationships
- Create a positive climate
- Encourage community partnerships
- Promote the wise use of leisure time and generally enhance a strong sense of community
- Sustain giving programs

With this as a great starting point, it will be the role of the Department to translate the current mission into a NEW set of goals, replacing those listed, above along with clear objectives, and action statements that use the information in this plan to lay out five years of tangible/measurable and reasonable statements

towards which the Department will work to “honor” the existing mission.

Harvard Business Review defines a vision statement as “what the organization wishes to be like ins some years time”. Furthermore, they define mission statement as “what business the organization is in”.

The Village of Monee Parks and Recreation Department knows its mission to provide recreational facilities and programming to the community. It needs to define its vision, with an eye toward the future.

A possible vision statement could be:

The Village of Monee Parks and Recreation Department will seek to evolve to a more balanced department managing both its parks and recreation services under “one roof”, seeking new resources other than tax dollars to improve and expand its existing services

Right now, it is observed that the Parks and Recreation Director is spending most of its time on recreational programming, is challenged by park issues, and needs to set some clear, defined goals for the future of parks and recreation in Monee. The Village and the Director of Parks and Recreation should give greater emphasis to parks matters moving forward creating a better balance of time and resources to both the parks and recreation programming components of this quality-of-life Department. Some suggested goals for the future will be found later in the plan in Chapter 3, but for now, our analysis has led us to this point.

To make clear, for the Village, how to look at setting goals, it might help to define them along with setting objectives and action statements to assure that those goals are achieved over the next five years.



Goals, Objectives, and Action Statements Defined

Strategic planning is a very important business activity. It is also important in the public sector areas such as education. It is practiced widely in both informal and formal structures. Strategic planning and decision processes should end with objectives and a roadmap or actions for ways to achieve them.

One of the core outcomes when drafting a strategic plan is to develop it in a way that is easily translatable into action plans. Most strategic plans address high level initiatives and overarching goals, but they don't get articulated (translated) into day-to-day projects and tasks that will be required to achieve the plan. Terminology or word choice, as well as the level at which a plan is written, are both examples of easy ways to fail at translating your strategic plan in a way that makes sense and is executable to all employees.

Often, plans are filled with conceptual terms which don't tie into day-to-day realities for the staff who are expected to carry out the plan. The following terms have been used in strategic planning: desired end states, plans, policies, goals, objectives, strategies, tactics and actions. Definitions vary, overlap and fail to achieve clarity.

So that you can work with this process, moving forward, we felt it was important to share this information with you, along with some definitions of these items that are quite functional:

- Goals
- Objectives
- Action Statements

One model of organizing how a comprehensive plan sets out the ways or methods by which it will accomplish "things" over the

coming years is by setting goals, objectives, and action statements in a hierarchy. The items listed, above, may be organized in a hierarchy by writing a goal, explaining specifically how the goal will be shown to be accomplished by writing an objective, and further detailing how staff will accomplish that objective by stating intermediate steps, known as action statements.

The Goal describes the "ideal" outcome.

The Objective answers the question "How?"

The Action Statements break down the "How?" into intermediate steps that staff use as a "TO-DO LIST" for getting the work done to accomplish the Objective.



02 Existing Conditions & Analysis / 2.4 Mission and Vision

With this in mind, here are the definitions:

Goals

Points to a place where you want to end up and not to a place you are today. A goal is a statement of general purpose or intent which shows some relation to the Mission of the Organization. In other words, if our mission is to provide high quality recreation programs for citizens of Monee, a goal would not be: To sell stamps to residents of Will County. On the other hand, a goal could be: To increase the number of Special Events offered by the Monee Parks & Recreation Department in the next five years.

A goal can also be said to be a statement of desired outcomes to which effort is directed. As such, goals can be achieved only to the degree that their meaning is understood. To do this, definition is given to a goal by writing one or more measurable statements, known as objectives;

Objectives

A specific measurable occurrence, product/service, or accomplishment that is made to achieve, or obtain an outcome in the future that will cause or demonstrate that a goal is being achieved. It usually states exactly what the end product will look like or appear to the customer with something that can be measurably evaluated. It also states who is expected to accomplish that objective, as well as by what date it will be accomplished. In order for the appropriate staff person to accomplish the Objective, they must spell out the specific tasks they plan to do to reach the Objective. These are the Action Statements;

Action Statements

They state what specific steps, along the way, will be taken to achieve the objective? Describe them in clear detail, and by what


date they will be accomplished by whom. Put them in chronological order. Think of these as a detailed “TO DO” lists for each objective.

It is recommended that the Director of Parks and Recreation begin the work of translating the information presented in this Comprehensive Plan’s analysis (Ch. 2.1-2.3) into clear, measurable and actionable goals, objectives, and action statements.

Setting goals, objectives, and strategies for the Village of Monee Parks and Recreation Department will be essential to the future of the department, and to afford it continued and growing success in the next five years and beyond.

Parks & Recreation

The Village of Monee provides and maintains a system of parks that offer a range of recreational amenities both passive and active. Until now, however, the Village did not have an adopted park classification system. Not all recreational spaces are meant to serve the same purposes and adopting a classification system will provide a tool for the Parks and Recreation Department to evaluate current uses and further program its recreational spaces. We offer the following park categories and their definitions that should be adopted into the Zoning Ordinance:

Until now, Monee has not adopted an ordinance stating their intentions for park acreage per 1,000 residents which can help guide park development and planning for land acquisitions. Currently, the Monee Parks and Recreation Department does not advertise their two natural areas as shown in the Facilities Matrix above as open and available to the public for recreational use, so for our comparison purposes we should exclude that acreage, but these are available land assets that the Village should take advantage of in the future. Recommended improvements for these spaces will be outlined later in this chapter.



03 Needs & Priorities Assessment / 3.1 Park & Facility Assessment

Total park acreage offered between the four dedicated parks is 10.82 acres.

The National Recreation and Park Association (NRPA) recommends 10 acres per 1,000 residents, which for Monee would mean they fall short at 2.13 acres per 1,000 residents (using 5,082 current population data via US Census Bureau). However, it is no longer common practice to make general comparisons to the national averages because there is so much variation across communities regarding population, budgets, staff, available resources, and community needs and desires. Instead, a better method of assessment is that of benchmarking, a comparison to averages of communities that share similar attributes.






FIGURE 1: RESIDENTS PER PARK (BY JURISDICTION POPULATION)

The *2020 NRPA Agency Performance Report* provides median values for communities based on populations, but more importantly highlights the lower quartile averages (lowest 25%) and the upper quartile averages (highest 25%). As shown in the Report Figures 1 & 2 (opposite page) for populations less than 20,000, Monee should likely strive for standards of no more than 1,300 residents per park and no less than 5.2 acres per 1,000 residents. With 4 total park spaces, Monee averages 1,270 residents per park which is in line with where they should fall. Adding the two Natural Areas would increase their overall acreage to 19.51 for an average of 3.84 acres per 1,000 residents which starts to bring them more in line with what they should strive to achieve.

It is recommended that the Village adopt the following standard:

5 Acres of Park Land per 1,000 Residents





- Salt storage relocated near new Public Works building, and building demolished
- Re-purpose existing Village Hall building for Recreation if Village Hall is ultimately relocated
- Relocate larger playground site just west of Recreation building with new and accessible playground equipment for all age groups
- Consider area north of football field for potential sport courts, e.g. tennis/pickleball, basketball, sand volleyball
- Create additional paved pedestrian connections between park amenities providing ultimately for an accessible looped walking experience throughout the park
- Expand parking lot along Court Street and Elmwood Lane frontage
- Add (2) small picnic shelters/pavilions that could be used for rentals and generate revenue; one in location of old playground and one north of future recreation building/current Village Hall
- Determine if future recreation building expansion is needed and feasible north of current Village Hall
- Create additional detention facility in NW corner of park if required with facility/amenity development
- Additional trees and landscaping in strategic locations throughout the park to frame spaces and provide shade

Recreation & Program Assessment

As a Department of the Village, it is generally observed that the Parks and Recreation Department is quite strong in its Recreation Management, overall. An assessment of the Recreation and Program functions of the Department can help modify, improve, focus and guide the Department to be:

- Clearer in its purpose.
- Efficient in use of staff time for programming.
- Focused on key program areas.
- Defined in its budgeting and allocation of resources.

Overview

First, let's give some consideration to broad observations and assessments of the Recreation/Programming aspects of the Village with a focus specifically on program strengths and weaknesses and facility strengths and weaknesses.

Our assessment, here, is drawn from a three-year review of recreation programming at the Village of Monee using a tool referred to as a "Program Evaluation Cube" developed by J. Robert Rossman at Illinois State University (see Appendix).

It is essential to understand that the village should be proud of the diversity of its programming given the population size served. Clearly, the emphasis on programming over the past three years has paid great dividends.



PROGRAM STRENGTHS

- Over 116 different types of programs offered with 221 different sessions of those programs being spread out over the last three years.
- Programs Offered for a great number of age groups from pre-school through older adult.
- The age group of 5 to 12 has the highest number of programs offered which seems to parallel the demand for programming identified in the community wide survey.
- Most other age groups have between 6 and 12 percent of the program offerings which reflects a strong balance across age groups.
- The Village is especially strong in its offerings for Sports and for the Visual/Performing Arts.
- After Sports and Visual/Performing Arts Programming, SPECIAL EVENTS is quite strong.
- Cancellation of programs is nearly NON-EXISTENT in the “Under 5” Age programming.
- A MODERATE number of cancellations occur in the Adult, Active Older Adult, and Older Adult Age groups.

PROGRAM WEAKNESSES

- The program cancellation rate is 47%, a bit high compared to national averages that run closer to 35%.
- There are program areas that are completely without current program offerings including:
 - » Aquatics
 - » Camps
 - » Trade/Technical Programs
 - » Environmental Programming
- Some age groups have very little programming offered for them. These would include:
 - » Young Adults: 18 to 25
 - » Adults: 25 to 55
 - » Older Adults: Over 72
- Cancellation of programs is VERY HIGH in the High School and Young Adult Age groups.
- A MODERATE number of cancellations occur in the Adult, Active Older Adult, and Older Adult Age groups.



FACILITY STRENGTHS

- Sports Fields are quite numerous and greatly used.
- The Village has recreation fields and buildings that other communities of its size lack.
- The neighborhood parks have playgrounds.
- The Community Building is relatively new and is well-used.
- Having a Community Building is better than what many communities the size of Monee have.
- Except for major sport days and special events, there is plenty of parking to support the Community Building.

FACILITY WEAKNESSES

- The Parks and Recreation “office” is LOST, and difficult for folks to find. Some emphasis will be placed on this in the Marketing and Branding information later in this Plan.
- The office space provided is essentially a storage area, not designed for public interaction, or productivity.
- The Pavilion that adjoins the Community Building needs complete replacement.
- Playgrounds need renovation in some cases, and ADA Accessibility review and modifications.
- Classroom space in the Community Building is not very functional.
- Classroom space, overall, does not lend itself to expanding or diversifying programming.
- Sports field orientation and drainage are major challenges.
- Parking for Special Events and Busy Sport Days is Restrictive.



Recreation Program Focus

Many large communities work very hard to offer a broad group of programs to meet the needs of various ages, various interests/ activity preferences, and special events as they feel it essential to provide services to all taxpayers. In smaller communities, with less diverse resources, it is essential to choose/focus on specific program areas, do them well, and establish a reputation for quality, successful programming. Monee has taken its first steps towards provision of quality recreation programming, and needs to be careful not to push too far beyond its human and financial resources. Careful weighing of priorities, and setting an eye on efforts for the next five years will help Monee Parks & Recreation to continue to grow without trying to do too much.

Farnsworth Group uses a process of review of basic program statistics using a tool known as **The Program Evaluation Cube (see Appendix)**, to bring light to matters such as:

- Where too much time is being spent on programming.
- What programming is “succeeding”, or not.
- What is trending in recreation programming in the Village of Monee.
- How programming is reaching residents, or not.


Let’s take a look at some broad areas of comparison of existing programming in Monee, based upon three years of programs offered in Monee, AND the user data from those programs

Percentage of Programming Overall by Age

The clear impact of Monee recreation programming is being felt by those individuals aged 5 to 12—where 36% of Monee programming has been attempted. This is not an uncommon age group to focus on for successful recreation programming in many communities where recreation is being offered.

Three other age groups—5 and under, 12 to 15, and high school age—garner 37% of Monee’s attempted programming, combined (12%, 13%, and 12%, respectively) of the village’s programming.

That leaves four other age groups—young adults, adults, active older adults and older adults—to share the smaller, remaining piece of the programming puzzle.

Percentage of Programming by Activity Type

It is not surprising to find that 31% of all programming offered in Monee is sports related, followed closely by 30% of attempted programming in the visual arts category. Now, if you combine this with performing arts programming, which garners 7% of Monee's program offerings, then the arts category programming is actually greater than sports programming at 37%.

Special events makes up 16% of the programming in Monee, as the only other "large" programming category offered by Monee Parks & Recreation.

All other programming offered combines for the remaining 16%:

- Social
- Continuing Education
- Health/Fitness
- Skill Development

Monee does not currently offer these other common areas of programming found in most other communities:

- Aquatics
- Camps
- Technical Skills
- Environmental Education



Program Cancellations by Age and Activity Type

The program evaluation cube showed that a lot of planning and preparation work went into programming for Young Adults- Ages 18 to 25, High School Age, Older Adults- Ages 72+, and Middle School- Ages 12 to 15. All of it, however, with very little success; high cancellation rates of programming in these age groups was a direct result of a lack of sufficient enrollment in order to successfully run the program.

This bar graph below shows that while SPORTS and VISUAL ARTS programming have the greatest number of programs offered, overall, they also have the two largest cancellation rates. In and of itself, this does not mean too much, as a 61% cancellation rate in sports still means a lot of programs are reaching a sufficient enrollment level to run the program.

Many people consider a high cancellation rate to be negative in all respects. The perspective Monee Parks & Recreation should understand is that a cancellation rate that is high—above 35%—should tell its staff that:

1. Much planning and preparation is being done for naught. Offer a little less, and use the “saved” planning time to promote, better, the programs you do offer.
2. Attention must be given to assuring that you are offering programs that are really of interest to the age group you are offering them to, or to your population in general.

For example, a program area like SOCIAL ACTIVITIES, where 7 programs were offered and 47% were cancelled means that very few SOCIAL programs were of success and/or reached as many as it might if the “success rate” (opposite of cancellation) were higher. Staff should consider this in the future as it plans for SOCIAL programming.

Recreation Management Focus

Part of the overall assessment process by Farnsworth Group came through:

- Direct Observation
- Interviews of Staff, Community Leaders and Elected Officials
- Review of Current Systems and Policies within the Village
- Public Prioritization Process with Trustees and Staff

We have used these various approaches to get at core issues that should be considered by the Village of Monee as it plans and carries out its Parks & Recreation functions over the next five years of this plan. Many of these steps will allow the Village to greatly advance its successes in:

- Programming
- Sourcing Funds Other Than Tax Dollars: Grants, Donations,

Sponsorships

- Park Improvements
- More Efficient Management

Farnsworth Group recommends the following items need serious consideration in the planning horizon of this long-range plan:

Program Budget Procedure

The cornerstone of any successful governmental budgeting process for parks and recreation includes the distinct and clear delineation of Operating Budget and Capital Budget for Parks and Recreation, each year. Furthermore, it requires that the Trustees and Village Administrator include the Director of Parks and Recreation in the creation of both of those budgets, annually. Regular attendance of the Director of Parks and Recreation at all Council Meetings, and inclusion in Department Head meetings with Public Works and the Village Administrator could all assist in developing the Director of Parks and Recreation’s appreciation for the challenges of the overall Village of Monee Budget and the Management Challenges of Police, Fire, Public Works, etc.

Individually, the Director of Parks and Recreation should:

- Develop a Trustee Approved Pricing/Fee Philosophy
- Develop a Trustee Approved Delineation of:
 - » What Portion of the Village Budget will be Allocated to Parks & Recreation
 - » What Portion of the Parks & Recreation Budget must be Supported by Program Fees and Charges
 - » What Portion of Program Fees will Contribute to Overhead Costs
- Create a well-defined fee structure for use of:
 - » Ball Diamonds
 - » Sports Fields
 - » Pavilions/Shelters

- » Score Boxes/Concessions
- » Bathrooms
- » Buildings/Classrooms
- Define Which User Groups Pay More, OR Less for the Various Use Fees, above.
- Establish a clear budget tool to determine the cost of each program, and guide it in setting a fee to charge for those programs, which factors:
 - » Direct costs of the program
 - » Indirect costs of the program
 - » “Markup” Policy

Niche or Gap Assessment

This management component will require annual, or every-other-year assessment, by the Director of Parks & Recreation, with input and policy/prioritization guidance from the Village Administrator and Trustees.

Basically, the Director of Parks & Recreation should use The Program Evaluation Cube tool to:

1. Observe cancellation rates by:
 - a. Age Group
 - b. Activity Type
2. Observe how much programming is being offered for each age group, and determine:
 - a. If the time being spent is worth the number of people being reached
 - b. If the budget cost committed to that programming is worth the number of people being reached
 - c. If the current staff can keep achieving the level/number of programs being offered
3. Identify “new” program areas or “trends” and budget to add those programs, while dropping others.

4. Conduct community surveys to assure program needs are being met.
5. Ask the Village Administrator and Trustees to define the “limits” of your resources, and:
 - a. Which age groups should be highest priority with limited resources
 - b. Which activity types are highest priority given the facilities and parks available to offer them



Marketing and Branding

Perhaps the single most significant factor that stood out in the Parks & Recreation Survey conducted for the Village of Monee was the response to Question 3:

How likely would you be to recommend the DEPARTMENT to a friend or Family member?


Notably, two-thirds of respondents are what survey professionals would label as “Detractors”

The Oxford English Language Dictionary defines a “Detractor” as “a person who disparages someone or something”. While the Farnsworth Group does not feel that its residents are disparaging the efforts of the Parks & Recreation Department in Monee, the Village should take considerable note of this survey-finding.

Indeed, Monee Parks & Recreation should be very proud of what it is doing for its residents in terms of parks and recreation. However, all planning for the future, as guided by this Plan, should factor the importance of the finding of this survey question into its efforts toward improvement. Taxpayer expectations are often at the root of these matters, and should be weighed heavily by the Parks & Recreation Director, the Village Administrator, and the Trustees.

Survey comments related to this question focused on:

- Lack of knowledge of parks available
- Lack of knowledge of recreation programming available
- Lack of variety in programming
- Not enough programming
- Not enough special events
- Quality of parks and/or facilities

Residents can always find criticism for programs and services in the community in which they live. That will never end. What the Village of Monee must take to heart is the core/overall impression which is reflected in the graphic on the previous page.

Nonetheless, don't overlook the positives:

- 78% of your residents surveyed have visited one of your parks in the last year
- 44% of your residents surveyed have attended at least one organized program in the last year

Both of these statistics come very close to the national averages as reported in NRPA's *2018 Americans' Engagement With Parks Report*, which as discussed previously are not always good benchmarks, but in this case these statistics are good indicators of the quality of the parks and programs being offered.

What is often the core CAUSE of the "lack of knowledge", OR the "not enough" comments are:

- Weak Communication
- Lack of Marketing or Clear Message
- Need for Greater Public Involvement/Input to What Programming and Park Issues Should Be Addressed
- Ease of Access to the Monee Parks & Recreation "PRODUCT".
- Understanding How to "Compete" with Others Who Offer Recreation

To reduce the number of program cancellations.....

To increase the number of program participants.....

To help more residents to find their nearby parks.....

To inform residents/taxpayers of the variety of programming available.....

All of these require stronger MARKETING and BRANDING of Monee Parks & Recreation.



Marketing

Alayna Frankenberry, of BLUESKY Marketing, elaborates on what Marketing is in recreation and parks:

“While many businesses sell tangible items, recreation marketing exists to sell experiences. As you can imagine, convincing a customer to purchase a skydiving trip is a lot different than convincing them to buy a t-shirt with an airplane on it. Recreational activities are about learning new skills, making memories with your family, or relaxing after a stressful work week. Selling concepts like these comes with some unique challenges.”

How does one capture an “experience”? It is with feelings, emotions. These are not tangible in nature, but it is what people feel when they visit a Monee Park, or participate in a Monee Recreation Program.

To communicate these valuable, fun, exciting, eventful, athletic emotions and feelings one uses a variety of “tools of the trade” in marketing:

- Advertising
- Promotion
- Social Media
- Public Input and Involvement

Has the Village of Monee Parks & Recreation Department allocated sufficient resources to use these tools to communicate to its residents?

Branding

Harold J. Nolan, Jr. wrote in the National Recreation and Park Association magazine:

“The positive perception of any recreation, park and tourism organization is both a desired and required goal. In reaching this goal for such leisure-based services, the process is based in part on a positive branding image. In today’s environment, without a strong and positive brand image, bad things may happen. If you are a manager of a public recreation, park and tourism agency, you may have had these types of situations happen to you or observed them in surrounding communities:

- *An increase in competition from other public- and private-sector providers has begun to erode your services*
- *Your community’s parks division has merged with public works or another municipal department*
- *Both the operating and capital budgets have been reduced at a greater rate than other departments within a community*

If these and other situations related to a loss of status are occurring within your organization, it may be that your agency’s brand is weak.”



So what does “BRANDING” involve?

First, the Village of Monee should make a commitment to include parks and recreation as a priority along with fire, police, streets, sanitation, water, public works and other services.

Second, Monee Parks & Recreation should decide what emotions, feelings and experiences it believes are most important to its residents. Are you:

- A place to come to relax?
- Fun, Sun, and Run?
- Learning, Growing, Enjoying?

This will require Monee Parks & Recreation to “capture” the mood/feeling/emotion it wishes to PERMEATE all its MARKETING (see, above, for information regarding marketing).

Then, “Branding” will take that emotion/feeling/mood and translate it and use it in every marketing method it uses—all to cultivate a certain image in the minds of Monee Residents and the Customers of Monee Parks & Recreation. You don’t need to hire a marketing firm to do this, but you must be creative, factor in the character of Monee—both physically and of its residents—and be sure that whatever this mood/emotion/feeling might be that when you conduct the steps below you hold true to it in everything you do:

- Choosing a name
- Designing a logo, tag lines
- Using colors, shapes, and other visual elements in its social media, services and promotions
- Crafting the language in its advertisements
- Training your employees to interact with customers

Third, the Monee Parks & Recreation Department should decide who its customers are. None of the process involved in creating a unique name and image for Monee’s Recreation and Parks “product” in the consumers’ mind, through branding or advertising will work without knowing who your customers are. Branding aims to establish a significant and differentiated presence in the market that attracts and retains loyal customers.

The Village of Monee should understand that your primary customers are your residents within Village boundaries who pay taxes to support your facilities, staff, and programs.

As mentioned in Section 2.2, The Village of Monee should be heartened to learn that only 16% of its residents indicated they were going to other communities for their recreation programming—not as significant as many of the Staff and Trustees had thought when they spoke to us.

Nonetheless, it is essential that Monee Parks & Recreation begin to realize that customers from “other places”, will come to you if you BRAND and MARKET your product correctly.

- A customer is willing to drive up to 5 miles, without hesitation to get a product or service they want.
- If a product or service earns a reputation or “image”, a customer will drive up to 10 miles without hesitation.

It is recommended that the Monee Parks & Recreation Department:

1. Reach out to its residents more frequently and clearly.
2. Develop a stronger BRAND.
3. Commit greater resources to its Marketing “TOOLS of the TRADE”.
4. Reach beyond its Village Borders for customers.
5. Make people from the 5 and 10 mile radius come to Monee to use Recreation Programming and its Parks.

Precursor

As briefly addressed in Section 2.4, the Village of Monee Parks and Recreation Department knows its mission. It needs to define its VISION with an eye toward the future.

As the Village has grown and evolved, so should the Monee Parks and Recreation Department.

The Village has its mission, but it needs a **VISION**.

The analysis provided in Chapters 2 & 3 is leading the community to a new phase in its provision of parks and recreation services. Just as the Village is in the process of completing its *2021 Comprehensive Plan* to “guide future development in Monee for the next 15 to 20 years.....”, so, too, must Monee Parks & Recreation be prepared to move forward.

If Monee wants Parks and Recreation to be prepared to move along with its *2021 Comprehensive Plan* it should adopt a VISION that accomplishes what a VISION sets out to do. Remember, Harvard Business Review defines a vision statement as “what the organization wishes to be like in some years time”. In the case of this Plan Document, the next five years. Without VISION, Monee Parks & Recreation will remain where it is today.

Farnworth Group suggests that the time is now for a VISION to go along with its existing MISSION.

We provide the previous Chapter 2 and 3 analysis and assessment as a “guide” to a possible vision statement.

We recommend:

VISION STATEMENT

The Village of Monee Parks and Recreation Department will seek to evolve to a more balanced department managing both its parks and recreation services under “one roof”, growing its recreation programming, improving its existing parks, developing its unused open space, while managing its resources wisely.

To achieve this VISION, we provide in the next two sections the core, specific details of this Plan.



Recommendations

In section 2.4 there were some goals presented as part of the analysis of existing condition. Those CURRENT GOALS are stated as:

1. Advance the reputation and image of the Village.
2. Be responsive to the recreational needs of all individuals.
3. Build relationships.
4. Create a positive climate.
5. Encourage community partnerships.
6. Promote the wise use of leisure time and generally enhance a strong sense of community.
7. Sustain giving programs.

Now, with a new VISION for the next five years, it is essential for Monee Parks & Recreation to set NEW GOALS. The Director of Parks & Recreation was charged by Farnsworth Group to help define these goals. TEN total goals were identified by the Director — five for Parks and Facilities and five for Recreation. The Director of Parks and Recreation began to write OBJECTIVES and ACTION STATEMENTS to accomplish these recommended GOALS over the next five years. The Village Administrator and Trustees should review, provide input towards, and approve these GOALS, OBJECTIVES and ACTION STATEMENTS no later than March 2021.

We recommend that the Trustees adopt these ten GOALS as part of the Village of Monee Parks and Recreation Comprehensive Plan.

PARKS

Goal 1: Make improvements to the football field and large baseball field at Firemen’s Park to resolve drainage and other playability issues for the football field and large baseball field.

Objective A: To apply for matching funding via the OSLAD Grant FY22 in 2021.

Action Statement 1: The Director of Parks & Recreation should meet and discuss the standings of the grant and updated information needed starting in August 2021.

Action Statement 2: First rough draft should be completed by October 2021.

Action Statement 3: A revision should be completed by December 2021.

Action Statement 4: The first review should be conducted by the board by January 2022.

Action Statement 5: The final version should be presented for the Board approval by February 2022.

Objective B: The Director of Parks & Recreation should budget for the matching monies that are required for this matching grant.



PARKS

Goal 2: Build new centrally located concessions building at Firemen’s Park to include functional and accessible public restrooms to address lack of public restroom facilities identified for this community park.

Objective A: The Parks & Recreation Director and the Village Administrator should interview with the board approved grant consulting firm to discuss plans and proposal of plans that are needed and required for to apply for the PARC Grant and any other grants.

Objective B: To apply for funding via the PARC Grant FY22 in 2021.

Action Statement 1: The Director of Parks & Recreation should meet and discuss the standings of the grant and updated information needed starting in August 2021.

Action Statement 2: First rough draft should be completed by September 2021.

Action Statement 3: The first review should be conducted by the board by beginning October 2021.

Action Statement 4: A revision should be completed by end of October 2021.

Action Statement 5: The final version should be presented for the Board approval by December 2021.

Objective C: The Director of Parks & Recreation should budget for the associated grant administration fees and 25% monies of overall project cost that are required for this grant.

Goal 3: Conduct a thorough ADA Compliance analysis at all Parks and Facilities which concludes with a “Transition Plan.”

Objective A: The Parks & Recreation Director should create a matrix of all parks and facilities to be evaluated and enlist services of a consulting firm to evaluate these spaces for compliance with current ADA codes and guidelines.

Objective B: The Parks & Recreation Director should evaluate the final ADA compliance report and Opinion of Probable Costs provided by the consulting firm and prioritize and schedule improvements to be outlined in a Transition Plan that aligns with available funding.



PARKS

Goal 4: Seek to improve and add recreational amenities within existing Village parks and open spaces at appropriate locations, i.e walking paths, play equipment, landscaping, sport courts, etc.

Objective A: The Parks & Recreation Director should meet with the Village Administrator to discuss improvement needs of existing Village parks.

Objective B: The Parks & Recreation Director should meet with the Village Administrator to discuss open spaces and additional land the Village has marked for potential parks.

Objective C: The Village of Monee Board should adopt an Open Space Ordinance to reflect an appropriate standard for how much acreage the Village will set aside per 1,000 residents.

Objective D: The Parks & Recreation Director should budget for yearly additions and or improvements in accordance with a schedule of yearly additions or improvements.

Action Statement 1: The Village of Monee should approve this money needed during its fiscal budgeting process and approve of said budget.

Goal 5: Seek to acquire more land/buildings for expanding the Parks & Recreation Department.

Objective A: The Village of Monee Board should revise their Land/Cash Ordinance to reflect an appropriate standard of acreage and/or funds in lieu of required to be given to the Village upon development.

Objective B: The Director of Parks & Recreation, the Village Administrator, and the designated Parks & Recreation Trustee should meet on a quarterly basis to discuss any information on possible acquisitions for land/buildings that may arise as a result of information that is collected.



RECREATION

Goal 6: Seek to expand affiliation and partnerships with area colleges, forest preserve and other municipals/park districts in the area to expand programming and avoid duplication of services.

Objective A: The Director of Parks & Recreation should continue to keep up communications with these partnerships quarterly.

Action Statement 1: Through these partnerships you can connect with local college sports program and collaborate with them about camps for the community to connect not only the Village of Monee but to better connect the residents to services offered and make known the relationship between the Village of Monee and said connections with these organizations/resources.

Goal 7: Improve the existing use of area schools and improve the IGA to allow for additional space to provide recreation.

Objective A: The Director of Parks & Recreation should meet with CMSD #201U Superintendent on semi-annual occasion to discuss the possibilities that could be available to the Village of Monee for recreation purposes.

Action Statement 1: The use of the school's facilities can help expand the programs that are offered to residents for sports programs such as basketball and volleyball programs through the use of IGA that the Director of Parks and Recreation will develop with the CMSD #201U.

Action Statement 2: The IGAs that are developed need to be presented and approved by both the Village of Monee Board and the CMSD #201U Boards.

Goal 8: Broaden the awareness, recognition and image of the Village of Monee Parks & Recreation Department using: Online registration, Stand-alone Brochure, Website and Facebook presence.

Objective A: The Director of Parks & Recreation should get 3 bids from program developers to be installed and utilized.

Objective B: The bids should be presented to the Village of Monee and voted upon.

Objective C: The Director of Parks and Recreation should budget accordingly.

Objective D: All Parks and Recreation staff should be trained on this new software.



RECREATION

Goal 9: “Grow” recreation programming so that the department can financially afford to hire more program staff, so that the Parks and Recreation Director can shift some focus towards parks issues more regularly resulting in balanced efforts in both areas.

Objective A: Recreation staff should be hired to help plan and work programs the community wishes to see more of.

Objective B: Survey after each program what the participants liked or didn’t like to continue to improve programming.

Goal 10: Continue to take on more youth programs and develop more sports programs, in general, to utilize the land and amenities available to the Village, and as improved at Firemen’s Park.

Objective A: The Director of Parks and Recreation should stay in contact with the Monee Mavericks Football Team quarterly and continue to offer to house them under the Village of Monee.

Objective B: The Director of Parks and Recreation should continue to survey the public on their interests in various sports.

Action Statement 1: By keeping up with the interests and trends in the area could open the doors for possible sports programs such as Lacrosse, soccer, etc. seasonal programs.

Additional Goals

In addition, Farnsworth Group recommends these additional goals for the next five years:

Parks and Facilities

- A. Update Land/Cash Ordinance to reflect an appropriate standard of acreage and/or funds in lieu of land required to be given to the Village upon new development.
- B. Park Category System shall be adopted by the Village that identifies hierarchy of park types, their definitions, size parameters, and purposes
- C. Transition management of parks maintenance and oversight to Director of Parks and Recreation---OR remove that responsibility from the job description.
- D. Identify potential pedestrian/bicycle routes to connect parks and open space within the Village, as well as potential for regional connections.
- E. Have existing park facilities/buildings retro-commissioned to identify problems that might need to be addressed based on age, equipment type, and building usage.



Recreation

- A. Narrow the focus of Activity Type offered in recreation programs.
- B. Establish a defined group of Ages that the department will focus its programming towards.
- C. Limit the addition of new Special Events.
- D. Focus on quality and not quantity of programs.
- E. Create a “Brand” for the Monee Parks & Recreation Department.
- F. Reach out to its residents more frequently and clearly.
- G. Commit greater resources to its Marketing “TOOLS of the TRADE”.
- H. Reach beyond Village borders for customers. Make people from the 5 and 10 mile radius come to Monee to use Recreation Programming.
- I. Develop a Trustee Approved Pricing/Fee Philosophy
- J. Develop a Trustee Approved Delineation of:
 - What Portion of the Village Budget will be Allocated to Parks & Recreation
 - What Portion of the Parks & Recreation Budget must be Supported by Program Fees and Charges
 - What Portion of Program Fees will Contribute to Overhead Costs
- K. Create a well-defined fee structure for use of:
 - Ball Diamonds
 - Sports Fields
 - Pavilions/Shelters
 - Score Boxes/Concessions
 - Bathrooms
 - Buildings/Classrooms
- L. Define which user groups pay more, or less for the various use fees above
- M. Establish a clear budget tool to determine the cost of each program
- N. Conduct a Niche or Gap Assessment as defined in Section 3.2



04 Vision / 4.2 Capital Prioritization

The goal of Capital Prioritization is to identify possible projects, which align with our recommendations and goals stated earlier in this chapter, then prioritize decisions for investing in and developing these projects. The prioritization of these projects is again only a recommendation and the Parks and Recreation Director along with the Village Administrator may at any time decide to rearrange their priority to implement specific projects sooner, or postpone others based on community need, recreation trends, and funding opportunities. Based off of community and stakeholder input gathered throughout the plan process, we understand that the desires and needs of Monee residents are greater than the current funding resources available. Therefore, it is important that Master Plans be developed for each park and construction budgets determined.

05 Implementation Strategies / 5.1 Funding

The Village of Monee's financial health plays a vital role in what the Parks and Recreation Department can be expected to accomplish in terms of providing and maintaining parks and providing and increasing recreational opportunities that the community expects of them. The FY21 operating budget for the Parks and Recreation Department totals \$258,671.30, less than 2% of the Village's overall operating budget. According to the 2020 NRPA Agency Performance Review, median annual operating expenditures per person for agencies with populations less than 20,000 is \$96.77 per person (lower quartile is \$56.34). The Village of Monee Parks and Recreation Department currently spends approximately \$50.89 per person. This average per person dollar amount is calculated accurately for the budget amount indicated, but upon our review we found several Parks and Recreation line items for recreation facilities, park maintenance and park improvements listed under the Buildings & Grounds Operating Budget. It is our recommendation that a thorough review be completed and ALL parks and recreation items be included under a single "Parks & Recreation Department" budget for FY22. It should also be evaluated how the funds are being allocated within the overall budget. Average percentage distribution of operating expenditures to strive for would be 44% going to management and maintenance of parks/open space and 43% going to recreation and programming and the facilities for these activities with the remaining 13% going to other.

For the recommendations and goals outlined in this plan to be realized, it is recommended that the Village make additional financial commitments and allocations to the Parks and Recreation Department over the next five years. It is equally important that sources other than general fund tax support be contributing to the Parks and Recreation Department Operating Budget. On average, park and recreation agencies get three-fifths of their funding from general fund tax support with the remaining sources coming from a combination of:

- 24% Earned Revenue
- 8% Dedicated Levies
- 3% Other Dedicated Taxes
- 2% Grants
- 1% Sponsorships
- 2% Other



Funding Opportunities: Grants

There are several types of grants that can be applied for that could assist in funding various project types. Grant applications may require a Comprehensive Plan such as this, park master plans, and or scope of work and fee proposals. The following are some of the options Monee may seek to consider:

Federal Grants

- Community Development Block Grant Program (DCBG): Administered by Will County, these federal monies are allocated by HUD for low- & moderate-income communities to pay for public infrastructure.
- Surface Transportation Program (STP): These federal funds are administered by IDOT and managed and allocated by the Will County Governmental League and CMAP. Designed primarily for roads, these funds can be used for multi-use paths along designated FAU Routes.
- Federal Trail Program (FTP): Administered by the US Department of Transportation, this grant is designed for off-road trails for motorized and non-motorized off-road vehicles.

State Grants

- Illinois Department of Natural Resources (IDNR) Open Space and Land Acquisitions Development Grant (OSLAD); This program is targeted specifically to parks and open space projects that fund outdoor recreation improvements and land acquisition for park space.
- IDNR Park and Recreational Facility Construction Grant (PARC); This grant program is targeted to indoor recreation facilities that serve the public.
- Illinois Transportation Enhancement Program (ITEP): administered by IDOT, this federally funded grant is designed to enhance transportation options including off-road multi-use paths.
- Illinois Bicycle Path Program: An IDNR grant program targeted to municipalities to fund off-road bicycle paths & trails.
- Rebuild Illinois Public Infrastructure Grants: As a part of the \$45 billion Capital Plan initiated in 2019, Illinois will provide grant funds through the Department of Commerce and Economic Development (DCEO) for public infrastructure improvements for parks and recreational facility construction. These funds will be allocated through FY 2025.

Financing

One avenue that many municipalities with parks & recreation departments utilize to fund improvements to facilities, existing parks and open space and park land acquisition is bond financing, such as through General Obligation (GO) Bonds. These provide long-term financing to improve capital investments that serve the public and enhance community development.

Legislative Prerogatives

From time to time, State and federal legislators can assist a municipal government in acquiring funding through special prerogative funds. In 2019, this was a significant part of the Rebuild Illinois Plan, and several park projects were funded by monies set aside for each legislator for their districts. We would highly recommend that the Village reach out to their State Representatives and Senators to assist and support Monee's efforts to improve their park space.



Partnership Opportunities

Partnering with local and regional organizations can give the Monee Parks and Recreation Department the ability to leverage unique working opportunities to the benefit of both parties and its residents. There are three basic categories of partnerships that should be sought: intergovernmental, affiliate, and corporate.

Intergovernmental Partnership

Potential intergovernmental partnerships for Monee Parks and Recreation Department to seek and cultivate are:

- Crete-Monee School District 201U to allow for shared indoor recreation space for basketball, volleyball and more
- Forest Preserve District of Will County, use of Raccoon Grove Nature Preserve and Monee Reservoir to allow for additional outdoor, nature-based programming opportunities and also development and implementation of shared programs at these locations
- Governors State University

Affiliate Partnership

Affiliate partnerships typically occur with community-based organizations such as churches, sports clubs and private interest groups. While these affiliate partners may be self-benefitting and difficult to maintain relationships with due to changing leadership, they can also provide important opportunities for Parks and Recreation. The groups again might have indoor recreation space to share, but specific interest groups and sports clubs can often times offer advanced programs to build off of beginner classes offered by the Parks and Recreation Department. Such organizations in Monee that the Parks and Recreation Department already has formed partnerships with are:

- Monee Alliance of Churches
- Fitness Premier Monee
- Monee Historical Society
- Maverick Youth Football and Cheer
- Challenger Sports (Soccer Camp)
- Monee Chamber of Commerce
- Monee American Legion
- Wil-Kan and Kan-Wil Baseball and Softball League

Corporate Partnership

Securing corporate partnerships should become a focus for the Parks and Recreation Department towards building a successful financial future. We recommend the development of a third party 501(c)(3) Park Foundation that can fundraise and accept private donations, that are tax deductible to the extent the law allows, to support and improve various parks and recreation activities as best determined by those overseeing it. While the Parks and Recreation Department might benefit through monetary donations, purchase of equipment, and team sponsorships, the corporate

partners benefit through brand exposure and high level visibility to the users and program spectators. Currently, the Parks and Recreation Department receives funds from corporate partners as individual/event-based sponsors. To realize additional benefits, these types of partnerships need to be a multi-year commitment and developed based on a predetermined tier system that clearly defines expectations and responsibilities of both parties. For example, a sponsorship program might be developed with three tiers named “Gold”, “Silver”, and “Bronze” where the largest commitment made by both parties would start with “Gold” and taper down with “Silver” and even further still where “Bronze” would be the lowest commitment made. The corporate partners could be presented a “menu” of annual events and programs to choose from that could further tailor their benefits by reaching a target market group specific to their needs, or an event theme that aligns with their business.

The overall success of this Comprehensive Plan lies with the Village and the Parks and Recreation Department's desire to execute it. This plan was developed to be implemented over the course of five years, but the individual goals and objectives outlined herein shall be reviewed annually. The Village Administrator and the Parks and Recreation Director should give consideration to the development of a Park Commission to assist in these reviews. This committee would be comprised of Monee citizen volunteers and duties would be advisory in nature only, to review items of importance to the Parks and Recreation Department under the guidance of the Parks and Recreation Director, and then to make recommendations regarding these issues to the Village Trustees. In 2025, the Village Administrator and the Parks and Recreation Director should prepare to update this Comprehensive Plan and engage the community and stakeholders in planning for the next five years, and beyond.



Executive Summary

Introduction

Public Research Group conducted a Parks & Recreation Survey for the Village of Monee Parks & Recreation Department in the summer of 2020. The survey sample covered all Village of Monee residents via a postcard that was mailed out in early June 2020 informing residents to complete the survey on-line. Public Research Group has compiled 179 on-line surveys. The sample of 179 households provides a margin of error of plus or minus 7.2% at a 95% confidence level. This information should be valuable to review and develop an understanding of the survey information that has been collected in relation to the master planning process.

Major Survey Findings

The survey contained a series of questions that were designed to measure behavior as well as perceptions by residents surrounding mostly parks & facilities, but also included recreation and administration. Furthermore, there were several opportunities for participants to provide specific comments from “open end” questions.

➤ How likely would you be to recommend the Department to a friend or family member?

This is a measure of customer satisfaction and loyalty to the Village Parks & Recreation Department. The Net Promoter Score (NPS) system was used with NPS scores are measured with a single question survey and reported with a number from -100 to +100, a higher score is desirable. Given the NPS range of -100 to +100, a “positive” score or NPS above 0 is considered “Good”, +50 is “Excellent”, and above 70 is considered “World Class.” Based on global NPS standards, any score above 0 would be considered “good.” The Parks & Recreation Department had a score of -51, which is considered a poor score with much work to be done in the future to raise this score.

➤ Participation in Programs

Nearly half of respondents and their families have not participated in organized recreation programs held by the agency last year. This is possibly due to the Village Parks & Recreation Department does not offer programs for their age groups, which there is a demand for more programs for young children and adults. When asked about new or additional programs, the numerous responses collected from the survey respondents varied but several repeating themes included wanting more active activities, including sports like basketball, gymnastics, dance, yoga, and swimming. Along with active activities, there were common social activities included STEM programs, art and cooking classes, and events including wine tasting and tabletop gaming.

➤ Do you feel that the Village of Monee should continue to invest in the parks and recreational programming?

There is strong support for the Village to continue the investment into the parks and programming for the overall benefit of the local community. In comparison of data generated from related questions in this survey in terms of quality of life, satisfaction and the open-ended responses, there is a strong correlation between the effort given in time, resources and overall commitment by the Village that many in the community do not believe that parks and recreation has received the proper attention it has been in the recent past.

➤ How often do you visit a park in Monee?

A majority of respondents have visited a park in Monee 7 or more times last year. This shows that the parks are often used and enjoyed by the residents.

➤ If the Parks & Recreation Department would consider improvements at Fireman’s Park, what park features that would be most important to you and your family?

The top three park features that are important to respondents to add or improve at Fireman’s Park were the football field, playground equipment and concessions building.

➤ Do you or members of your household use any outside agencies for parks, facilities, recreation programs and/or services?

Respondents and their households take part in numerous outside parks and facilities, recreation programs and services. This includes visiting forest preserves, neighboring Park Districts, and the library. The open-ended responses included sporting events, daycares, Leo Hassett Community Center in Manteno and other town’s basketball and volleyball courts.

➤ If you or members of your household use outside agencies, what are the reasons?

Respondents go to outside agencies instead of Monee Park and Recreation due to programs their interest in not being available through the village. These outside agencies provided better programs, were closer to home, provided outdoor recreation and were better organized.

➤ In thinking overall about parks and recreation in the Village of Monee, please rate each of the following priorities which would be important to you and your household.

The respondents favored expanding recreational programs, expanding opportunities for more community special events and building more pathways as a high priority. Just keeping everything the way it is now scored low for future priorities.



Major Survey Takeaways


- Parks & Recreation Department has not reached its full potential in meeting the expectations from the local community.
- Park spaces seem very basic and do not generate much excitement for the average resident.
- The parks are used frequently with Fireman’s Park being the most visited.

Introduction

Public Research Group compiled 179 on-line surveys. The sample of 179 households provides a margin of error of plus or minus 7.2% at a 95% confidence level. This information should be valuable to review and develop an understanding of the survey information that has been collected in relation to the planning process. The survey questions illustrated in this report are not in the same sequence as the survey document as the questions have been arranged by essential parks and recreation topic areas.

Administration

Q3: How likely would you be to recommend the Department to a friend or family member?




Conclusion: This is a measure of customer satisfaction and loyalty to the Village Parks & Recreation Department. The Net Promoter Score (NPS) system was used with NPS scores are measured with a single question survey and reported with a number from -100 to +100, a higher score is desirable. Given the NPS range of -100 to +100, a “positive” score or NPS above 0 is considered “Good”, +50 is “Excellent”, and above 70 is considered “World Class.” Based on global NPS standards, any score above 0 would be considered “good.” The Parks & Recreation Department had a score of -51, which is considered a poor score with much work to be done in the future to raise this score.



Q3a: What is the most important reason for your score?


Conclusion: The open-ended responses were centered on not knowing what is available, a lack of variety in the programming, not many programs or activities for non-children households and a lack of special events.

Q4: Would you agree that the Monee Parks & Recreation Department contributes to your quality of life?



Conclusion: The percentage (44%) that agrees is relatively low as a comparative to completed surveys over the past few years. The typical response is around 70% that would agree that the agency contributes to the respondent's quality of life.


Q5: Do you feel that the Village of Monee should continue to invest in the parks and recreational programming?



Conclusion: There is strong support for the Village to continue the investment into the parks and programming for the overall benefit of the local community. In comparison of data generated from related questions in this survey in terms of quality of life, satisfaction and the open-ended responses, there is a strong correlation between the effort given in time, resources and overall commitment by the Village that many in the community do not believe that parks and recreation has received the proper attention it has been in the recent past.



Q6: How would you rate your overall satisfaction with the Monee Parks & Recreation Department?




Conclusion: The percentage (25%) of respondents that were satisfied is low as a comparative to completed surveys over the past few years. The typical response is around 40% that would rate past experiences with the agency as satisfying.

Conclusion: The open-ended responses were centered on canceled programs, no significant capital improvements for the past few years, a lack of bike trails, grocery stores and teen and adult programming.


Q23: Please make any additional comments that you think would be helpful for the staff to hear about.


Recreation


Conclusion: Programs named included STEM programs, sports, arts, dance and swimming.

Conclusion: Programs were somewhat similar to the first age group named includes basketball, gymnastics, volleyball, arts, sports, dance and fitness type classes like yoga.




Q18: Of the top TWO age groups you selected, are you willing to pay a fee to participate in these programs?

Parks and Facilities


Q1: How many times have you or your family visited a park in Monee within the last year?



Conclusion: A majority of respondents have visited a park in Monee 7 or more times last year. This shows that the parks are used on a frequent basis.




Q1a: Did any of the following factors prevent you or a household member from visiting a Village park? (Check all that apply)

Q8: Do you or members of your household use any of the following listed below for parks, facilities, recreation programs and/or services? (Check all that apply)








Q10: Which of the following parks do you or other members of your household use?
(Please check all that apply)




Conclusion: Of the parks in Monee, Firemen's park was the most used park.

Q11: Which of the following parks do you or other members of your household use most often?




Conclusion: Like the previous question, Fireman's Park is the most often used park in Monee.

Conclusion: Over half of the survey respondents lived closest to Fireman's Park.


Q13: Regarding the park closest to your home, please rate the feelings of you and your household.



Conclusion: Since Fireman's Park is centrally located within the Village, it can be assumed that it is used the most due to the park being accessible, safe and clean.




Q14: Please rank the TOP THREE park features that would be most important to you and your family to add or improve at Firemen's Park.



Q20: How long have you lived in Monee?


Conclusion: The average residency is 14 years.

Conclusion: A majority of survey respondents identified themselves as female, which is common since women are more likely to take part in social science surveys.

Conclusion: It should be understood that children under the age of 18 do not respond to community surveys. With that being said, the average age of respondents to this survey was 29 years old. Of the households surveyed, 52% had children 18 or younger and 24% of households had active adult/senior citizens.

Conclusion

Overall, the survey data collected and analyzed is very typical of small parks and recreation agencies. It is a challenge to provide a high level of service with limited resources. In review of the survey responses, there is much work to be done to meet future community expectations. The parks seem very average and do not generate much excitement for the average resident unless you have a need to participate in an organized team sport. The feeling of the information collected from the survey seems like the Department has not reached its potential and has regressed a little as compared to the past. The net promoter score of -51 from Question 3 is very poor as compared to other agencies we have surveyed in which 2/3rds of the respondents would not recommend the Department. This correlates to Question 6 in terms of only 1 out of 4 is satisfied with the Department. Athletic fields, dog park, splash pad and trails are important capital improvements to the community. In the future, residents would like to see an investment made into the parks with an expansion of recreation services offered.

- It's hard to recommend a department. The festival in the fall has always been great and enjoyable, but group programs for kids is significantly lacking in my opinion. There are very few options for activities/sports, and most of the programs for preschool aged kids is limited to a morning time with no alternative afternoon time (my son is in preschool at that time and can't ever attend). We participated in the t-ball program last year and I felt that it was very expensive for the quality of the program. I was told that last year was the first year the village had taken over the program, so I do understand issues coming up with the transition. Most times you had moms and dads taking care of the fields. We are in desperate need of tennis courts, basketball court, walking path, a pool maybe, decent baseball fields for the kids etc.
- There are a lot of kids in this community and I feel as though it would benefit the community to support the parks department. The parks that I've seen are clean and well-kept but seem a little under-utilized compared to other towns I've lived in such as Homewood and Flossmoor to the north. Open spaces, nature walks, and playgrounds can turn a town into a home which feels lush, vibrant, and inviting to its residents. You can own a home anywhere, but to call your town home takes something special. Monee almost has that home town feeling, it just needs a little more walking/biking accessibility along some of the busier streets, and somewhere to get ice cream.
- Acquire new land for parks? Really? How about building in the existing vacant park in Gorman?
- I think the new mayor does not support the football team like previous mayors. No one is our walking the streets to discover what walkers (specifically ME) encounter. There are not sidewalks everywhere. Some existing sidewalks are in bad condition. People don't trim their trees or bushes. I have to duck to walk under some trees, and walk in the grass to walk around untrimmed bushes. Cars park over sidewalks, and again I am walking in the street. There are many many homes that have hoses draining onto the sidewalks, from gutters and who knows what else. In cold weather this makes the sidewalks icy. And if it isn't cold, some of these hoses also deposit mud onto the sidewalks, and that can be slippery as well. Aren't there codes about that? Shouldn't these hoses be emptying into drain tiles? And there are some inconsiderate people who, on trash day, place their garbage cans in the crosswalks, once again making me walk in the grass. I don't think that there should be fees for these because my taxes keep going up up up up and I don't see any amenities in return for the increases. You've already collected enough money. Also, for dog owners, there should be a dog park right here. Why should Monee residents have to drive to 394 to use a dog park? We have to drive to another town for everything.
