Proposals will be publicly read aloud at 10:01 A.M. on Friday, May 10, 2024. No bid shall be withdrawn after the opening of the proposals without the consent of the Village President and Village Board for a period of ninety (90) days after the scheduled time of closing bids.

All proposals shall be sealed in an envelope, addressed to the Village of Monee, Attention Clerk's office. The name and address of the bidder and the name of the project shall also appear on the outside of the envelope. Proposals must be submitted on the forms provided by the Engineer.

The Bid Documents, including specifications, are on file at the office of the Engineer, Robinson Engineering, Ltd., Phone: (815) 806-0300, email: reladministrative@re ltd.com, and may be obtained electronically via email upon review of pre-qualification information. The bid documents will be issued to Contractors for requests received until 12:00 P.M. on Thursday, May 9, 2024.

A bid bond or certified check/bank draft drawn on a solvent bank, payable without condition to the Village of Monee in an amount not less than ten percent (10%) of the bid shall be submitted with each proposal, as a guarantee that, if the proposal is accepted, a contract will be entered into, and the performance of the contract is properly secured.

equal to one hundred percent (100%) of the amount of the bid, with sureties to be approved by the Village President and Village Board for the faithful performance of the contract, must be furnished by the successful bidder. All bids or proposals shall contain an offer to furnish bond upon acceptance of such bid or proposal.

The right is reserved to reject any or all proposals, to waive technicalities, to postpone the bid opening, or to advertise for new proposals, if in the judgment of the Village President and Village Board their best interests will be promoted thereby. All bids shall remain subject to acceptance for 90 days after the time set for opening bids. The Contractor is advised that no work can begin on the project until the Village obtains all required permits and construction easements.

The Contractor will be required to pay not less than the prevailing wage rates on this project as established by the United States Department of Labor. The Contractor shall also comply with all applicable Federal, State and local regulations.

Pre-qualification will be required to be submitted to the Engineer by all potential bidders prior to receiving any bid documents. IDOT prequalification is required for this project. Bidder qualifications and experience will be included in the basis for determining the lowest responsible bidder. If in the opinion of the Engineer and the Village President and Village Board, an applicant would not be able to serve the best interest of the Village, a proposal will not be issued to the applicant.
