



The Mayor, Trustees and the Village Staff, would like to announce the Village's 4th consecutive Residential Tax Relief Program with the following guidelines. To qualify for tax relief the applicant:

- Must be an owner-occupied home – A property owner living in a single family home, a town home, a residential condominium unit within a building that they own is eligible for a refund.
- Owners of single family homes, townhomes and condo units are eligible to receive their refund once they prove residency in the home with a current Illinois driver's license or state identification card listing a Monee address. Owners of multi-unit apartment buildings must be living in one of the units to qualify for the refund. Property taxes on the entire building will be prorated to determine the amount paid by the single unit occupied by the owner. **APPLICATIONS MUST INCLUDE**
 - A copy of the County of Will 2023 Levy Property Tax Bill
 - A copy of your current valid Illinois driver's license or Illinois state identification card. All individuals on the tax bill must provide a valid driver license or state ID and must also sign the application.
- Must reside in the home at the time application is submitted.
- Original documents (i.e. tax bill) are not accepted. Village personnel will not be allowed to make copies under any circumstances. Applicants must bring/enclose copies of all requested materials.
- The relief check will not be processed if a past due bill, ticket or violation is owed to the Village at the time of application, or if the 2023 property taxes are not paid.
- Failure to submit complete and accurate information by the deadline will result in rejection of your application
- Sellers of property should enter into an agreement with buyers of the same property regarding disposition of any refund, which the buyers receive for taxes paid by the seller. Agreement documentation should list the name, phone number of the seller, the seller's signature, and must include the name(s) of the buyer(s) to whom the agreement to release the rebate for the 2023 taxes should be paid to.
- Applicants that have provided trust/death certificates to the village previously will not have to resubmit these documents.
- **THE PROPERTY TAX REBATE APPLIES ONLY TO THE VILLAGE OF MONEE PORTION OF THE TAX BILL.**

All applications and supporting documents must be submitted to the Village Hall by Friday September 26th @ 4pm. Checks will be available for pickup at the Village Hall by homeowner during the month of October as follows:

Monday & Wednesday Evenings 5pm – 7pm
Tuesday & Friday 9am – 5pm
Saturday 9am -12pm

- ☐ Copy of 2023 PROPERTY TAX BILL, which was paid in 2024. Internet copies of property tax information will be accepted and can be obtained at <https://willtax.willcounty.gov/ccalm07.asp>. You will need your permanent index number (PIN). **SEE ATTACHED EXAMPLE**
- ☐ COPY of your current Illinois driver's license or state identification card listing the homeowner's **Monee address**. **If the address on your ID is not a Monee address, other acceptable identifying information would include a copy of your current utility bill with Monee address. You must still provide, however, Driver's licenses or State ID cards for any/all names listed on the property tax paperwork.**
